RELEASE & WAIVER OF LIABIILTY

In consideration for engaging the car washing and car detailing services provided by Smart Wash (the "Provider") to be performed on Allegion's parking lot (the "Service" or "Services"), the undersigned Participant, acknowledges, appreciates and agrees as follows:

<u>Representations</u>. I am aware of the risks associated with engaging the Services including, but not limited to, the risks and dangers of serious injury from the activities involved with the Service including, in some instances, damage to property, theft, misappropriation of property, death, the risks of other participants' behaviors, as well as the risk of engaging the Provider for the Services.

- 1. <u>Assumption of Risk</u>. I agree that it is my responsibility to determine whether I am sufficiently fit and healthy to safely engage the Provider to perform the Services and whether Provider is sufficiently capable to perform the Service. As such, I knowingly and freely assume any and all risks, both known and unknown, whether such risks are caused by me or the negligent acts or omissions of any third party.
- 2. Waiver, Release, and Discharge. I understand and admit that my engaging the Provider to perform the Services is voluntary and not a condition of my employment. I hereby fully release, waive, and discharge Allegion plc and its respective parent company, respective subsidiaries, sectors, divisions, affiliates, and their respective officers, directors, employees, attorneys, agents, successors and assigns (collectively referred to hereafter as "Employer Group") from and against any bodily injury to myself or my property, any claims, costs, damages, debts, demands, expenses (including attorneys' fees), liabilities, liens, obligations, rights, and suits arising out of or related to the Provider and the Services, whether caused by negligence of the Employer Group or otherwise.
- 3. <u>Agreement Not to Sue</u>. I agree to refrain from commencing or participating in any action or suit against Employer Group that is in any way connected with the Provider or Services.
- 5. Agreement to Indemnify, Defend, and Hold Harmless. I, on behalf of my heirs, assigns, personal representatives and next of kin, hereby agree to release, indemnify, and hold harmless Employer Group from and against any and all claims, costs, damages, debts, demands, expenses (including attorneys' fees), liabilities, liens, obligations, rights, and suits asserted by any third party that is in any way connected with my acts or omissions or involvement with the Services and the Provider.

By signing this Release & Waiver, I acknowledge that: (a) I am over 18 years of age and of sound mind, and (b) have fully read and understand the statements made above and voluntarily agree to the Release & Waiver.

This Release & Waiver is intended to be as broad and inclusive as is permitted by the laws of the State of Indiana. If any portion of it is held invalid, it is agreed that the balance shall continue in full force and effect. It is agreed that this Release & Waiver shall be governed by, construed, and enforced in accordance with the internal laws of the State of Indiana.
